- 1. All items are sold as is where is. There is no guarantees or warranties, expressed or implied. ALL SALES ARE FINAL. There will be NO REFUNDS.
- 2. All announcements made on auction day supersede all past announcements
- 3. The auctioneer makes no guaranty that any items sold today conform to any safety standards, or are of a age, make, model or condition as listed in our catalog and encourages all bidders to do their own research and bid accordingly.
- 4. If you are the highest bidder when item is announced sold you are now the owner of said item, even though you may not have paid for it yet. The items are the sole responsibility of you, the bidder from this point on and assumes all risk of loss or damage.
- 5. Should any disputes arise between one or more bidders, the auctioneer has the sole opinion to sell the item to the highest bidder or put the item up for sale again.
